

**SUMMARY ANNUAL REPORT
FOR GERRITY'S SUPERMARKET, INC. RETIREMENT PLAN**

This is a summary of the Form 5500 Annual Return/Report of Employee Benefit Plan for the Gerrity's Supermarket, Inc. Retirement Plan, EIN 23-2150407, Plan 001, for period January 1, 2023 through December 31, 2023. The Form 5500 annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your plan is a defined contribution, profit-sharing, total participant-directed account, Code section 401(k), Code section 401(m), default investment account, pre-approved, controlled or affiliated service group member, single employer type of plan.

Basic Financial Statement

Benefits under the plan are provided through insurance and through a trust fund. Plan expenses were \$2,477,881. These expenses included \$38,847 in administrative expenses and \$2,439,034 in benefits paid to participants and beneficiaries. A total of 1,137 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$20,282,123 as of December 31, 2023, compared to \$18,600,759 as of January 1, 2023. During the plan year, the plan experienced an increase in its net assets of \$1,681,364. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$4,159,245, including employer contributions of \$72,933, employee contributions of \$716,623, other contributions of \$146,104 and earnings from investments of \$3,223,585.
